Sub: *Extension of timeline for Farmer Registration for ensuing Kharif procurement (KMS 2022-23)*


Ref: This Department letter No. 9834, dated 04.07.2022.

Madam/Sir,

In inviting reference to the letter on the subject cited above, I am to say that the last date for submitting the application for Farmer Registration for procurement of paddy (Kharif Crop) is hereby extended till **22.08.2022**.

2. The last date of digitization of forms by societies is also extended till **28.08.2022**.
3. Generation of Master Farmer List for procurement of paddy should, however, be ready by not later than **30.09.2022**.
4. Societies will entertain visiting farmers for registration by strictly enforcing social distance.
5. It is, therefore, requested to kindly circulate this message among concerned PACS/LAMPCS/WSHG/PPs through field functionaries for information of farmers in your district.
