**NOTICE**

Applications are invited from retired Group-D employees for re-engagement against the base level vacant posts of Peon in the office of the Registrar of Cooperative Societies Odisha, 7<sup>th</sup> and 8<sup>th</sup> Floor, Heads of Department Building , Unit-V, Bhubaneswar-751001 on contractual basis. The application in the attached proforma along with supporting documents should reach this Directorate latest by 16.10.2023 5.30 PM .

**Number of vacancies:** 7 (Seven)

**Eligibility Conditions:**

1. Employees who have retired from Government Service on attaining the age of superannuation and below the age of 65 years having good service records and are physically fit shall be eligible for re-employment
2. Employees against whom Departmental Proceedings or Criminal cases are contemplated / pending or who have been penalised for misconduct during the period of period of preceding five years will not be eligible for consideration.

**Selection Process:**

Selection will be made by a Selection Committee specifically constituted for this purpose through a dedicated selection process.

**Terms and Conditions:**

1. The re-employment shall be made initially for a period of one year or till the posts are filled up by regular process whichever is earlier.
2. Re-engaged employees will be entitled a consolidated remuneration of Rs.10000/- Per Month only.
3. Re-engagement shall be governed by the provisions of Odisha Government Servants' Conduct Rules 1957 and shall be liable to be proceeded against for their misconduct, omissions and commissions as per the provisions under the Odisha Pension Rules,1992.
4. The re-employment can be terminated at any time by the appointing authority due to unsatisfactory performance of the re-engaged employee

concerned by giving one month notice. On contrary if the re-engaged employee desires to resign she/he shall do so by giving one month written notice to the competent authority.
