2. ENROLMENT OF MEMBERS BY PRIMARY AGRICULTURE COOPERATIVE SOCIETIES (PACS /LAMPCS/FSCS):-

In the State of Odisha, 2708 PACS/LAMPCS are functioning at the grass root level primarily to provide agricultural credits and input to farmer members. With a view to rendering meaningful services, to the members Primary Agriculture Cooperative Societies (PACS/LAMPCS/FSCS) in the State, Member Contact Drive known as “**Cooperative at Your Door Steps**” was launched from 14th November to 30th November-2011. During the Member contact campaign, farmers have been motivated to become member of PACS, use KCC effectively for availing Crop Loan, open No Frill Account, etc. A progress as on date is tabulated below.

Again, “Cooperative at your doorstep” started from Dt.01.06.2018 till Dt.31.07.2018. During the programme 22252 JLGs formed and 16726 JLGs linked with credit.

3. KISSAN CREDIT CARDS.

Kissan Credit Card Scheme is introduced in the state through DCCBs and the PACS since 1998-99. The scheme aims at providing instant, timely, adequate and hassle free credit to the farmers on the basis of their land holding, cropping pattern and scale of finance, under the scheme. Once the credit limits for farmers are sanctioned crop wise, the same remains valid for 3 years unless modified/defaulted by the farmers. The

farmer members are supplied with Pass Book and Cheque Books to avail credit from 322 nos. of Branches of DCCBs.

7. Rupay KISSAN CREDIT CARDS –

A target for distribution of 18 lakh live KCC holders has been taken by the end of September,2017.As on date,1412137 cards have been distributed at the DCCB level.

8. INSURANCE SCHEME (PMFBY):-

- PMFBY has been introduced from Khariff 2016.
- Crops covered in our State: Khariff- Paddy, Groundnut, Cotton, Ginger, Turmeric, Red gram & Maize. During Rabi- Paddy, Groundnut, Mustard, Black gram, Green gram, Sugarcane, Sunflower, Onion and Potato are covered.
- Farmers covered: All farmers including share croppers, tenant farmers growing the notified crops in the notified area are eligible for coverage under the scheme.
- For loanee-farmers, the scheme is compulsory and for non- loanee it is optional.
- Gram Panchayat have been adopted as unit of insurance in respect paddy since Rabi 2010-11 Season.

12. PADDY PROCUREMENT :-

To provide adequate remunerative price to farmers for their surplus agricultural produce, PACS, RCMS and MARKFED were involved in paddy procurement operation under de-centralized procurement Scheme from 2003-04. MARKFED as the agent of the State Government and PACS as the sub-agent of Orissa State Civil Supplies Corporation have procured paddy from KMS 2010-2011 to 2015-16. From KMS: 2016-17(Khariff) onwards PACS are procuring paddy as Commission Agents of OSCSC, MARKFED & TDCC.

For the first time MSP has been paid directly to the bank accounts of the farmers through DFT platform of Odisha State Cooperative Bank in association with the Paddy Procurement Automation System (P-PAS) during KMS:2016-17 Khariff.The quantity of paddy procured by PACS and MARKFED is given below:

13. COMPUTERISATION OF PACS

The Hon'ble Chief Minister of Odisha has inaugurated the PACS computerization and launched RKCC on 01.07.2017. With computerization of PACS going on, 2301 PACS have gone online. Gradually all the PACS will be connected to CBS platform of OSCB. In view of this, 18 lakhs live KCC have been converted to Rupay Kissan Card so that farmers will be able to draw their sanctioned loan amount from any ATM, use P.O.S outlets of branch under National Payment Corporation net work.

14. AADHAR seeding of deposits & loan accounts in Coop. Banks & PACS-

Steps have already been taken for AADHAR seeding and validation of Registered farmers data base. As on date, 10,75,851 beneficiaries have already been seeded with AADHAR.

15. Mobile Banking in remote areas

Odisha is characterised by hilly and inaccessible terrain in tribal infested areas. With a view to providing minimum banking and financial services to the people in these areas. Initiative have been taken for providing Mobile Banking Services in these remote areas. The State Government, have provided Grants in Aid to the tune of Rs. 6.00 crores for this purpose.

16. Implementation of Core Banking Solutions (CBS) in OSCB, DCCBs and UCBs:-

With a view to enabling the OSCB, DCCBs and Urban Cooperative Banks in the State to compete with other Commercial Banks and provide services to the customers, the State Government have provided financial assistance to the tune of Rs. 39.00 crores for implementation of Core Banking Solutions in these Banks. The process of in OSCB & CCBs as well UCBs is completed.

17. Implementation of interest subvention scheme for dispensing crop loan @ 1% interest rate to farmers:

The Finance Minister in the budget speech for the year 2006-07 announced that Government of India will give subvention to NABARD so as to make short-term Argil. Credit (STC) available to farmers at 7% with an upper limit of Rs.3.00 lakh on principal amount .Further ST (SAO) loan has been financed to farmers @5% interest by PACS from 01.10.2008. Farmers will get subsidy @3% on interest rate in case of repayment of crop loan within due period with effect from 01.04.2011.

Further, the State Govt. have been providing interest subvention to the farm families for availing the Crop loans at concessional rate of interest of 4% to the farmers up to Rs 50000/- and at 5% interest to the farmers availing loans from Rs. 50001/- to Rs. 300000/- w.e.f. 1st October' 2015 . As interest incentive at the rate of 3% is available for prompt paying farmers, the effective rate of interest on Crop loan to such farmers are only 1% and 2% respectively.

18. Establishment of Agro Service Centres at PACS Level.

100 Agro Service Centers have been proposed to be set up in 100 PACS with Harvester Combine-1 Unit, Tractor(above 40 hp)-1 Unit , Cage wheel -1 Unit, Rotavator-1 Unit, MB Plough-1 Unit, Seed-cum- fertilizer drill -1 Unit, Trailor-1 Unit, Cultivator-1 Unit, Power sprayer-2 Units. The cost of these implements will be approximately Rs. 30.00 lakh and additional cost of Rs. 2.00 lakh towards capitalised cost of working capital totalling to Rs. 32.00 lakh as total cost of the project.

Till date, 100 PACS/LAMPCS have been selected by the State Level Committee for establishment of Agro Service Centers on basis of recommendation of District Level Committee forwarded by the DRCS.

19. Establishment of Agri-Clinic at PACS Level.

In order to cope with the emerging needs of the farmer members of PACS/ LAMPCS, efforts are being made to transform the PACS into One Stock Shop for delivery of agriculture related services. It was decided to establish Agri-Clinics to provide a host of services to the selected to PACS during the year 2014-15. Initially, Rs. 3.00 Crore has been sanctioned during 2015 for establishment of Agri- Clinics in 40 PACS. The total cost for establishment of Agri- Clinic would of Rs. 10.00 Lakh out of which Rs. 2.50 Lakh would be provided be beneficiary PACS and Rs. 7.50 Lakh by the State Government. Through Rs. 3.00 Crore has been drawn and kept OSCB Ltd., Bhubaneswar for the purpose, the selected PACS have not been provided as the approval of the Government has been sought. In the meeting held on 26.07.18 under the Chairmanship of Commissioner-cum-Secretary to Govt., Coop Dept., it is decided that the scheme will be taken up by APICOL and fund is to be transferred to APICOL.

20. FINANCING FOR SELF- EMPLOYMENT BY THE URBAN COOPERATIVE BANK :

At present 9 licensed Urban Cooperative Banks functioning in the State are providing finances for Self-employment to the unemployed youths and other minimum banking services like acceptance of deposit etc. in urban and sub-urban areas. Achievement in this sector is furnished below.

21. ESTABLISHMENT OF COMMON SERVICE CENTRES AT PACS LEVEL :

With a view to implementing National e-Governance Programme and providing essential services including Government to Citizens and Business to Citizens services, the Cooperation Department in collaboration with the Information Technology Department have launched a programme to establish Common Services Centres at PACS level. So far as on 31.03.2015, Common Services Centres have been established at 373 PACS. This has enabled PACS not only to render services to the people at remote places but also generate income for their sustenance. It is pertinent to mention that these centres have enabled PACS to generate additional revenue to the tune to Rs.3.00 Crores.

22. INFRA STRUCTURE DEVELOPMENT OF PACS/LAMPS:-

There are 2708 PACS/LAMPS are working in the state to cater the credit need of the farmers. At present these PACS are playing a vital role in the economic upliftment of the rural mass. These organizations are providing credit, Fertiliser & seeds to the farmers. Since infra structure is a basic requirement to achieve the target. Steps are being taken to strengthen the infrastructure like Godowns & office buildings of the PACS. The details of such are given here under.

(a) Construction of Godowns under RKVY:-

It was proposed to construct 298 Godowns at PACS level with a capacity of 300MT each with a financial involvement of Rs44.91 crores. Out of these 290 nos. of Godowns have been completed with a storage capacity of 87000 MT. Construction in respect rest 8 projects could not taken up due to non availability of suitable land at the PACS level and the said 8 projects have been recommended to Government for dropping.

(b) Construction of Godowns under RIDF Scheme:-

During the year 2013-14 it was proposed to construct 544 Godowns of different capacity in different Districts of Odisha under RIDF Scheme. Out of these, Government have sanctioned 398 Godowns for construction under the above scheme. out of this construction has been taken up in respect of 349 projects & construction has not been taken up in 49 Godowns due to non availability of suitable land in the concerned PACS. The State Government have released 183.00 crores for taking up to the Projects. So, 333 godowns have been completed and work in respect of 16 godowns are in progress.

(c) Construction of office building of the PACS/LAMPS:-

Financial assistance are being provided to the PACS / LAMPCS for construction of office building those have no office building of their own. Details of Financial Assistance provided to the PACS are given here under:-

(d) Construction of office building of ARCS / DRCS:-

Out of 19 Divisions, offices of 9 Divisions are running in rented building. In the mean time construction in respect of 2 Divisions are in progress & Administrative approval in respect of 1 Division office has been granted. Process of Alienation of land in respect of 4 Divisional offices are in process. No step has been taken by 2 divisions.

Similarly, Out of 58 circles, offices of 34 circles are running in rented building. In the mean time construction in respect of 5 circles are in progress & 2 circles have been completed. Administrative approval in respect of 2 circle office have been granted. Proceed of Alienation of land in respect of 21 circle offices are in process. No steps have been taken by 4 circles.

(e) Sanction of Grant in aid in favour of Odisha State Coop. Union:-

23. Construction of Infrastructure under Integrated Cooperative Development Project (ICDP) under assistance from NCDC:-

a. ICDP Koraput and Malkangiri:-

The ICDP project in the Districts of Koraput and Malkangiri was sanctioned by NCDC for Rs. 9.00 crores during the year 2001. The project started in the year 2006 and completed by 31.03.2013. Under the Scheme, construction of New godowns, shopping complex, Boundary wall, Mini Bank Counter , Paddy Procurement Platform, Office –cum- Mini Bank/ Mini Bank building and repairs of Godowns has been taken up at the LAMPCS Level. Details of the project undertaken is given here under.

There are 696 Godowns having capacity of 2.4 lakhs MT operated by 62 RMCs in the state. Besides 85 new Godowns having capacity of 62,500 MT is under progress. The details are furnished below:-

26. DISTRIBUTION OF CONSUMER GOODS UNDER PUBLIC DISTRIBUTION SYSTEM:-

Consumer Cooperative Sector has a three tier structure with the Odisha Consumers Cooperative Federation at the apex, 19 whole sale consumers cooperative stores at the central and all PACS and 314 Primary Consumer Cooperative Stores at the base level. These cooperatives sale consumer goods including distribution of controlled commodities under Public Distribution System Quality goods with right weighment at reasonable price is the hallmark of these societies.

27. RCMS

Out of 51 RCMS, 28 RCMS are distributing fertilisers, Kerosine and other essential commodities to the members in remote area.37 RCMS had Rice Mills. Out of which, 13 Rice Mills have been sold as plant and machineries have been obsolete.5 Rice Mills have been leased out to private parties. 19 Rice Mills are not functioning and in defunct stage.

28. COLD STORAGE:

There are 18 nos. of Cooperative Cold Storages installed in different districts in State of Odisha. Out of which 4 nos. of Cold Storages i.e., Nimapara Cooperative Cold Storage, Nimapara, Uttarayani Cooperative Cold Storage, Satsankha in Puri District, Bhubaneswar Cooperative Cold Storage in Khordha district and Jagatpur Cooperative

Cold Storage in Cuttack district are in running condition. One Cold Storage at Hindol in Dhenkanal District has been seized by Crime Branch. The cold storages at Jagatsinghpur and Bonai have not recorded land in the name of the Cold Storage. One Cold Storage at Rayagada, District-Rayagada is under the process of renovation by MARKFD. Out of rest 10 units of defunct cold storage, only 02 units of cold storage at Bayalish Mouza and Athagarh have their own recorded landed property in the name of respective Cooperative Cold Storages. As regards revival / modernization of Cooperative Cold Storage at Bayalish Mouza and Athagarh through PPP mode and leasing out of the same process has already been started.

Further, instruction have been issued to all Cooperative Cold Storages for alienation of land under their possession in the name of the respective Cooperative Cold Storage so that step for revival / modernization can be possible through PPP mode as per the decision of the High Level Committee Dt. 26.02.2015.

29. STORAGE FACILITY:

It is imperative that each PACS/LAMPCS should have adequate storage godowns for temporary storage of paddy and other agricultural produces including seeds. Besides, godown spaces are also required for prepositioning of fertilizers for use by the farmers at the time of their need.

Presently availability of godowns space in different PACS/LAMPCS – **498100MT**. A wide storage gap between requirement of godown and availability of godowns is persisting at PACS/LAMPCS level. Initiative have been taken for construction of godowns at PACS/LAMPCS level under different scheme.

1. RKVY: 298 godown at PACS level with a storage capacity of 300 MT each by availing financial assistance of Rs.44.92 crore under RKVY scheme.
2. RIDF: Under NABARD's Rural Infrastructure Development Fund (RIDF) construction of 544 godowns of different capacity like 300MT, 500MT, 1000 MT and 1700 MT at PACS level is going on. During the year 2015-16 Rs.90.00 crore have been drawn and paid to OSAM Board for utilization.
3. WIF: NABARD has agreed to provide Rs.736.50 crore under Warehousing Infrastructure Fund (WIF) to address the storage gap by constructing 2601 godowns in 27 Districts. During the year 2016-17 there is a provision of Rs.100.00 crore for the purpose.

30. COOPERATIVE SUGAR INDUSTRIES:

At present two Cooperative Sugar Industries namely Aska Cooperative Sugar Industries and Baragarh Cooperative Sugar Mill cane growers by providing marketing infrastructures, good remunerative prices for their cane and providing employment opportunity directly and indirectly to the people. Besides, these Sugar Industries provide high yielding varieties of seeds to the farmers and fertilisers and arrange credit support from Cooperative and other Banks under tie-up arrangement. Crushing performance and financial assistance provided to the above sugar industries are given below.

Besides, Bijayananda Cooperative Sugar Mills Ltd. Bolangir was registered under Odisha Self-Help Cooperative Act, 2001. After repeal of the OSHC Act 2001 in 2012, the Cooperative Sugar mill has cover under the Management of Government. The collector, Bolangir was nominated as MIC and the DRCS Bolangir Division as Secretary. The Sugar Mill has no ceased to function since April 2015.

Apart from that the Nayagarh Cooperative Sugar Industries was sold to M/S ECP Industries while Baramba Cooperative Sugar Industries to M/S. Balaji Sugar Allied Industries.

31. COOPERATIVE HOUSING SECTOR:

Housing Cooperative sector has a two tier structure with Odisha Coop. Housing Corporation at the apex and 106 Primary House Building Cooperative Societies. These societies provide long term loan to members for construction and purchase of residential houses, flats and core houses. The Odisha Cooperative Housing Corporation basically provide finance to its affiliated Housing Primary Cooperative Societies and also provide land and building to the members in Urban and Semi Urban area through its housing project. At present Odisha Cooperative Housing Corporation has taken up some key projects under Joint Venture Mode namely Multi-storeyed Housing Project i.e. at Tamando and 2 plotted scheme. Labany -I & II at Kuanarpur and Oltapur respectively. Labany -3 at Pattnaikia Chhak Puri & Paradeep Housing Projects are under progress. The total paid up share capital of the Corporation is Rs. 533.47 lakhs (2016-17) out of which Rs. 253.52 lakhs is invested by the State Government.

There was about 107 Primary Housing Cooperative Society functioning in the state and about 4.5 lakhs beneficiaries are benefited so far. The State Government has contributed share capital of Rs. 2.0 crores.

32. COOPERATIVE EDUCATION AND TRAINING

Member education and dissemination of information is one of the fundamental principles of Cooperative as enshrined in the principle of the cooperatives by the International Cooperative Alliance. The Odisha State Cooperative Union and 13 District Cooperative Unions and 17 Field Level Training Centres provide training and orientation to members and employees of the cooperatives. They also organise work shop and seminars to sensitise the members and inculcate the cooperative spirit and values. The Odisha State Cooperative Union has opened Utkal Gaurav Madhusudan Microfinance Training Institute at Bhubaneswar in 2003 to impart training to members of Micro Credit Institutions SHGS. The Madhusudan Institute of Cooperative Management, Bhubaneswar

under the aegis of National Council for Cooperative Training impart education and training with view to professionalization the human resources in cooperative sector. Achievement of these three premiers cooperative training Institutes during 2016-17 is furnished below.

Besides OSCB and the OSCU organised seminar and workshops, the Madhusudan Institute of Cooperative Management ,Bhubaneswar under the aegis of National Council for Cooperative Training impart education and training with view to infusing professionalization of human resources in cooperative sector. This Institute conduct long duration programmes like MBA, Diploma-in-Rural Management and Higher Diploma in Cooperative Management. Besides it conducted training and orientation programmes for employees of cooperative institutions and Central Cooperative Banks and OSCB.

33. PRICE SUPPORT SYSTEM(PSS):

The Government of India announces Minium Support Prices (MSP) for various notified Oilseeds and Pulses every Crop Season Under the Price Support System (PSS) for the purpose of protecting the interest of the farmers. As a part of its obligation MARKFED has undertaken procurement of the following.

34. SALE OF SEEDS BY PACS:

Sale of seeds at PACS levels not only helped the farmers, but also helped the PACS in generating additional revenue for their sustainable business development. 35. CREATION OF NEW CIRCLES AND DIVISIONS:

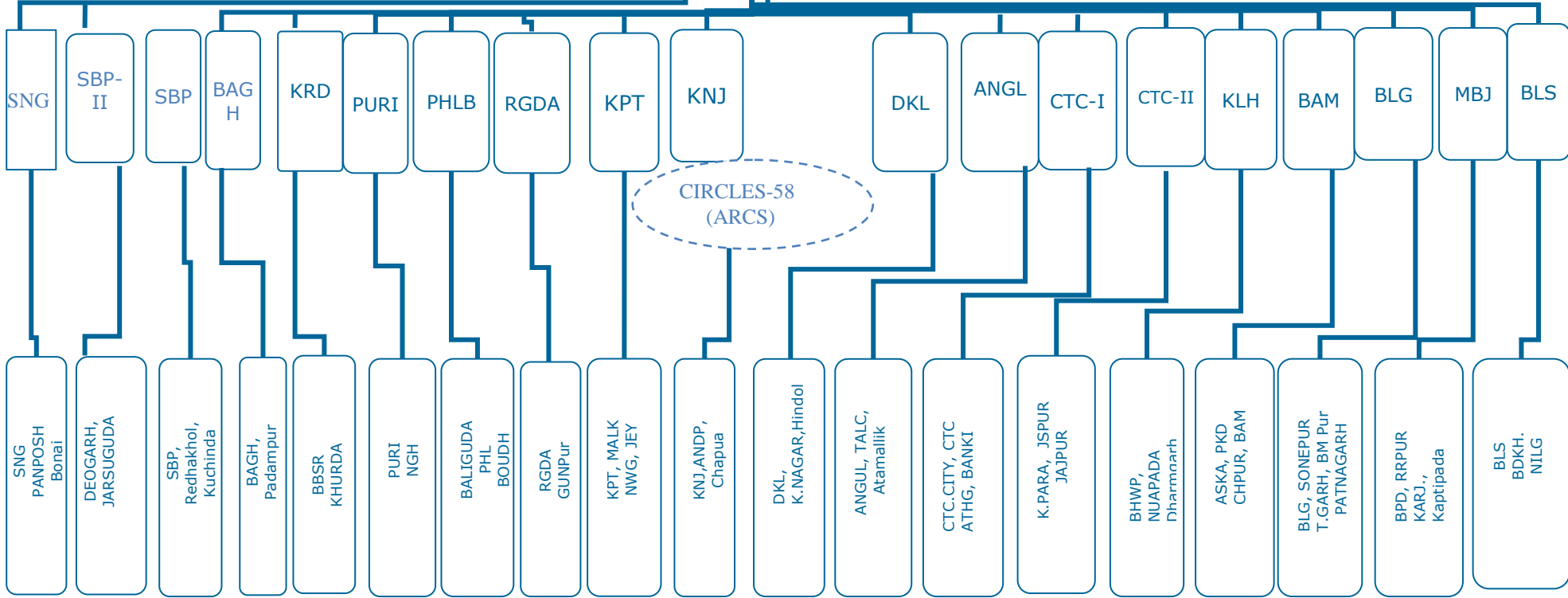

36. ELECTION OF COOPERATIVE SOCIETIES UNDER R.C.S.(O) AND OTHER DIRECTORATE.

Odisha is one of the first States to amend the Cooperative Societies Act, in February, 2012 in pursuance of the 97th Amendment of the Constitution of India. A separate statutory Body –namely the State Cooperative Election Commission, Odisha has been constituted and the State Cooperative Election Commissioner has been appointed. The State Cooperative Election Commission's office is functioning in the premises of the Odisha State Agricultural Marketing Board near Baramunda, Bhubaneswar. The State Cooperative Election Commissioner has taken up initiative for conduct of election of Members to the Committee of Management of different Cooperative Societies. In the mean time, election to the Committee of management of Primaries, Central and Apex Coop. Societies have been completed smoothly. Election process of 370 Nos. of primary left out cooperative societies has also been completed.
