NOTIFICATION

The 27th June 1981

S. R. O. No. 551781—Whereas the draft of certain rules further to amend the Orissa Co-operative Societies Rules, 1965 were published as required by sub-section (1) of section 134 of the Orissa Co-operative Societies Act, 1962 (Orissa Act 2 of 1963) in the extraordinary issue of the *Orissa Gazette* No. 450, dated the 16th April 1981, under the notification of the Government of Orissa in the Agriculture and Co-operation (Co-operation) Department No. 6867/AC (C) dated the 13th March 1981 as S. R. O. No. 237/81 inviting objections and suggestions from all persons likely to be affected thereby till the expiry of a period of thirty days from the date of publication of the said notification;

And whereas no objection or suggestion has been received by the State Government.

Now, therefore, in exercise of the powers conferred by section 134 of the said section, the State Government do hereby make the following rules, further to amend the Orissa Co-operative Societies Rules, 1965, namely :—

1. (1) These rules may be called the Orissa Co-operative Societies (Amendment) Rules, 1981.

(2) They shall come into on such date as the State Government may, by notification, appoint.

2. In the Orissa Co-operative Societies Rules 1965 (hereinafter referred to as the said rules), in rule 144. for the marginal heading and sub-rule (1) the following marginal heading and sub-rule shall be substituted namely :—

144, filing and disposal of appeal under Section 109 (1) An appeal under section 109 shall lie to such authority as specified in rule 144-A, and shall be presented by the appellant or by his duly appointed agent either in person during office hours or sent to it by registered post.

3. In the said rules, after rule 144, the following new rule shall be inserted, namely :—

“144—A. Appellate authorities—(1) An appeal under section 109 against an order or decision relating to matters specified in column (1) of the Table hereto annexed and passed by the authorities specified against it in column (2) thereof shall lie to the authorities having jurisdiction as specified against each in column (3) of said Table :—
